

## **CITY OF FORT WRIGHT, KENTUCKY COUNCIL MEETING**

**AUGUST 5, 2015 – 6:00PM**

Mayor Hatter called the meeting to order with a Pledge of Allegiance and a moment of silence. The following members answered roll call, Mr. Mike Hoerlein, Mr. Scott Wall, Mr. Joe Averdick, Mr. Dave Abeln and Mr. Adam Feinauer. Also present for the meeting were City Administrator Gary Huff, Attorney Kyle Winslow, Fire/EMS Chief Steve Schewe, Police Chief Dan Kreinest, Public Works Director Tim Maloney and City Clerk Joyce Woods. Mr. Bernie Wessels was unavailable for this meeting.

Mayor Hatter spoke to everyone about the article that was in the River City News regarding the discussion from a previous City meeting. We had a presentation of example of somewhat blighted or unmaintained properties at specific addresses that need to be cleaned up or items fixed. He advised that wasn't the idea of showing these properties, they were just examples of things that need to be done throughout the City. Mr. Averdick apologized because he was the one that took the pictures that showed the addresses.

### **Approval of Minutes**

Motion by Mr. Hoerlein, second by Mr. Feinauer to approve the minutes of the 07/01/15 Council Meeting. Roll call vote taken, Hoerlein, Feinauer, Wall, Averdick and Abeln voting in favor, no one opposed. Motion passed.

Motion by Mr. Averdick, second by Mr. Abeln to approve the minutes of the 07/15/15 Caucus Meeting. Roll call vote taken, Averdick, Abeln, Feinauer, Hoerlein, and Wall voting in favor, no one opposed. Motion passed.

Chief Dan Kreinest introduced our newest Police Officer Bradley Keller to Council. Officer Keller worked for Loveland Police for 10 years and also in the private sector. Mayor Hatter welcomed him to Fort Wright.

### **Executive Order 15-15 – Promotion of Jeffrey Hoppenjans to Police Specialist**

Mr. Winslow read this Executive Order. Motion by Mr. Averdick, second by Mr. Wall to approve. Roll call vote taken, Averdick, Wall, Hoerlein, Abeln and Feinauer voting in favor, no one opposed. Motion passed. Chief Kreinest stated that Officer Hoppenjans is a loyal and dedicated officer.

### **Approve in Concept the 2016-2020 - 5 –Year Street Plan**

Mayor Hatter stated that the City is back on a regular plan for street repair. Mr. Huff stated that each street is rated on a repair percentage and listed according to need of repair. Mr. Maloney advised that it is good to be back on track with the 5 -year Street Program. The last few years we have been very aggressive to get the needed repairs done. We also need to work with SD1 regarding repairs to the streets before they are done.
