Mayor Weaver opened the Council meeting with the Pledge of Allegiance and a moment of silence. The following members answered roll call, Mr. Dave Hatter, Mr. Paul Hiltz, Mr. Jeff Wolnitzek, Mr. Matt Barker and Mr. Joe Nienaber, Jr. Also present were City Administrator Larry Klein, City Attorney Pete Summe, Police Chief Dan Kreinest, Fire/EMS Chief Steve Schewe, Public Works Director Tim Maloney and City Clerk Joyce Woods. Mr. Adam Feinauer was not available for this meeting.

Second Reading of Ordinance 4-06 – Dump Truck Financing

Mr. Summe read this Ordinance in summary. Motion by Mr. Hiltz, second by Mr. Hatter to approve. Roll call vote taken, Nienaber, Wolnitzek and Barker voting in favor, no one opposed. Motion passed.

Second Reading of Ordinance 5-06 – RCD Zoning Map Amendment and Stage I Development Plan

Mr. Summe read this Ordinance in summary. Motion by Mr. Hiltz, second by Mr. Hatter to approve. Roll call vote taken, Nienaber, Wolnitzek and Barker voting in favor, no one opposed. Motion passed. Mayor Weaver thanked the developer of this project and welcomed them to the City.

Second Reading of Ordinance 6-06 – Amendments to Zoning Ordinance – Signs

Mr. Summe read this Ordinance in Summary. Mr. Summe advised there is some controversy, whether or not as it stands meets constitutional criteria. Several other cities had federal lawsuits filed against them and a decision was made to turn this over to NKAPC to work on this Ordinance. We consulted with other jurisdictions in other states that have taken this course to amend ordinances to meet constitutional challenges in court. Motion by Mr. Hiltz, second by Mr. Nienaber to approve. Roll call vote taken, Hatter, Wolnitzek and Barker voting in favor, no one opposed. Motion passed.

First Reading of Ordinance 7-06 – Text Amendment to Zoning Ordinance – OP Zone

Mr. Summe read this Ordinance in summary. This Ordinance adds funeral homes as a permitted use to this zone. Motion by Mr. Hiltz, second by Mr. Hatter to approve. Roll call vote taken, Nienaber, Wolnitzek and Barker voting in favor, no one opposed. Motion passed.

Motion by Mr. Hatter, second by Mr. Nienaber to adjourn to executive session per KRS. 61.810 (b) &(c). All members voting in favor, no one opposed. Motion passed.

Motion by Mr. Wolnitzek, second by Mr. Hiltz to adjourn executive session. All members voting in favor, no one opposed. Motion passed. There was no business conducted in this session.

Motion by Mr. Wolnitzek, second by Mr. Hiltz to adjourn legislative session. All members voting in favor, no one opposed. Motion passed.
